

 The Pre-Submittal calendar dates were created in order to show a modified deadline schedule to give the Planning Department an additional 20 days to process specific plans. This additional time is required in order to provide staff enough time to review each plan thoroughly and to provide the applicant with quality feedback. The Planning Department and other city staff will require no more than 20 additional business days in order to process the following plans:

- Site Plan (STP)
- Preliminary Plat (PPL)
- Annexation (ANX)
- Neighborhood Concept Plan (NCP)
- Planned Development (PDC, PDP, PDF)
- Rezone (Zoning Map Amendment, RZN)
